- Steel fabrication shop features; 10 MIGs, 2 steel cutting band saws, punch press, and solid steel set up tables.
- Wood milling contains a rip saw, 2 plywood panel saws, re-saw power feed band saw, 48” band saw, and 3 cut off chop saws.
- Assembly facilities contain 3 cut off chop saws, prep carts, pneumatic fastening equipment (nail guns etc.) and work stations that support over 50 employees.
- 3,500 sq ft bag department can manufacture unlimited sizes of custom gusseted barrier bags with 5 hand sealers.
- Shipping and receiving capabilities include 5 forklifts, 9 delivery vehicles, including a 53’ low boy tractor trailer semi-truck with wide load capabilities.
- Special resource access allows us to procure powder coating, special coatings, tube bending, fire resistant lumber, water jet cutting, CNC machining, Tig welding, transportation/shipping services, rail car loading, sea container loading and blocking & bracing.
